## MOTION FOR EXPEDITED TREATMENT AND APPROVAL OF TARIFF SHEETS

Comes now The Empire District Electric Company ("Empire" or the "Company") and for its Motion for Expedited Treatment and Approval of Tariff Sheets pursuant to 4 CSR 240-2.080(17) and 4 CSR 240-2.065(2), states as follows to the Missouri Public Service Commission ("Commission"):

- 1. On September 20, 2001, the Commission issued its Report and Order in the above-referenced matter, effective October 2, 2001, authorizing the Company to file proposed tariff sheets in compliance with said Report and Order.
- 2. Concurrent with the filing of this Motion, the Company is filing its proposed revised tariff sheets in compliance with the Commission's Report and Order. These tariff sheets bear an issue date of September 26, 2001 and an effective date of October 26, 2001. However, the Company requests that the Commission expedite its treatment and approval of these tariff sheets so that they may become effective on October 2, 2001.
- 3. It is appropriate for the Commission to expedite its treatment and approval of these tariffs. This case was implemented by a revised tariff filing on the part of Empire pursuant to § 393.150 RSMo 2000 and the Commission suspended those tariffs for the full statutory period. Accordingly, the operation of law date in this case, giving recognition to the full



suspension period is October 2, 2001, and Empire's initial tariff filing may not be suspended beyond that date. Stated another way, Section 393.150, RSMo provides that a public utility is not required to wait more than eleven months in total after the filing of revised tariffs to implement new rates where the Commission has determined, after full investigation and hearing, that the Company's existing rates are inadequate. That is the case here. Accordingly, there is good cause for the Commission to expedite its treatment and approval of these tariffs, namely compliance with the law, and for that reason there will be no negative effect on Empire's customers or the general public from the granting of this motion.

4. This motion is being filed as soon as it reasonably could have been filed since it is being filed concurrent with the tariffs and only six (6) days after the Commission's issuance of its Report and Order.

WHEREFORE, in light of the foregoing, the Company respectfully requests that the Commission grant its Motion for Expedited Treatment and Approval of Tariff Sheets and allow the subject tariff sheets to become effective on October 2, 2001, on less than thirty days notice.
