### MOTION FOR EXPEDITED TREATMENT AND NOTICE OF COMPLIANCE

COMES NOW Missouri-American Water Company (MAWC), and, in compliance with the Order issued by Missouri Public Service Commission (Commission), states as follows:

- On March 12, 2014 (effective March 22, 2014), the Commission issued its Order Approving
   Transfer of Assets and Certificate of Convenience and Necessity and Granting Waiver.
- 2. The Order requires MAWC to file a tariff adoption notice and index sheet for the existing Emerald Pointe Utility Company sewer tariff.
- 3. The Order also requires MAWC to file tariff sheets modifying its water tariff No. 13 to include service to the Emerald Pointe Utility Company service area.
- 4. MAWC hereby notifies the Commission that on April 4, 2014, MAWC filed the attached tariffs in compliance with the Order.
- 5. To show good cause for an expedited effective date pursuant to Section 393.140(11), RSMo and approval of the tariff sheets on less than thirty (30) days' notice, MAWC states that the tariff sheets have been filed in compliance with the Commission's Order herein and are designed to establish rates for the Emerald Pointe area upon the closing of the acquisition.

7. The subject tariff sheets and this Motion have been filed as soon as possible after the issuance of the Commission's Order.

WHEREFORE, for the foregoing reasons, MAWC respectfully requests the Commission to grant MAWC's Motion for Expedited Treatment and approve MAWC's proposed tariffs upon the filing of Staff's Recommendation, or as soon thereafter as the Commission finds to be reasonable.





## **Schedule of Rates**

Applicable to all water Customers located in the Company's certificated service territories.

#### **Water Service Rates:**

Monthly Customer Charge (5/8" meter) \$11.07 per month

Monthly Customer Charge (1" meter) \$25.52 per month

Monthly Customer Charge (2" meter) \$78.53 per month

Monthly Usage Charge (for all usage > 2,000 gal/month) \$0.71 per 1,000 gallons

Monthly Minimum Bill: Equals the applicable Monthly Customer Charge. The minimum monthly billing shall be billed Customer based on this charge. If a water meter is installed and in service the minimum monthly bill applies.

#### Taxes:

Any applicable Federal, State, or local taxes computed on billing basis shall be added as separate items in rendering each bill.

#### **Late Payment Charge:**

Billings will be made and distributed at monthly intervals. Bills will be rendered net, bearing the last date on which payment will then be considered delinquent. The period after which the payment is considered delinquent is twenty-one (21) days after rendition of the bill. A charge of five dollars (\$5.00) or three percent (3%) per month times the unpaid balance, whichever is more, will be added to delinquent amounts.

### **Returned Check Charge:**

A returned check charge of twenty-five (\$25.00) per check will be paid on all checks returned from the bank for any reason.
