MOTION FOR A NOTICE OF CORRECTION NUNC PRO TUNC CORRECTING THE NAME OF APPLICANT SENDERO SMGC LIMITED ACQUISITION COMPANY, LLC AND MOTION FOR EXPEDITED TREATMENT

COME NOW Sendero SMGC GP Acquisition Company, LLC ("Sendero GP Company"), and Sendero SMGC Limited Acquisition Company, LLC ("Sendero Limited Company")(collectively referred to as "Sendero") and DTE Enterprises, Inc ("DTE Enterprises"), and DTE Ozark, Inc. ("DTE Ozark") (collectively referred to as "DTE") by and through their counsel, and for their motion pursuant to 4 CSR 240-2.080 hereby request that the Commission issue a Notice of Correction Nunc Pro Tunc correcting the name of Sendero SMGC Limited Acquisition Company, LLC in its Order Approving Non-Unanimous Stipulation And Agreement And Approving Application which was issued on April 26, 2005. In support thereof, Joint Applicants respectfully state as follows:

1. On April 26, 2005, the Commission issued its Order Approving Non-Unanimous Stipulation and Agreement And Approving Application in this matter which, among other things, granted DTE Enterprises, Inc. and DTE Ozark, Inc. the authority to sell their respective limited

partnership interests in Southern Missouri Gas Company, L.P. to "Sendero SGMC LP Acquisition Company." (Order, p. 7). The correct name of the acquiring company is "Sendero SMGC Limited Acquisition Company, LLC" as evidenced by the Certificate of Organization from the Missouri Office of the Secretary of State which is attached hereto and incorporated herein by reference. This Certificate of Organization was also attached to the First Amended Application filed on March 30, 2005. However, the First Amended Application incorrectly referred to the company as "Sendero SMGC LP Acquisition Company, LLC" instead of "Sendero SMGC Limited Acquisition Company, LLC." As a consequence, the Commission's Order also refers to the acquiring company by an incorrect name.

- 3. Joint Applicants are planning to close the transaction on Thursday, May 26, 2005, if possible. Therefore, the Joint Applicants respectfully request that the Notice Of Correction Nunc Pro Tunc be issued as soon as possible. There will be no negative impact on customers, and this pleading was filed as soon possible after the error became apparent.
- 4. The undersigned counsel has contacted counsel for Staff and Public Counsel and they have no objection to this motion.

WHEREFORE, Joint Applicants respectfully request that the Commission issue its Notice of Correction Nunc Pro Tunc correcting the name of the applicant Sendero SMGC Limited Acquisition Company, LLC throughout the Order Approving Non-Unanimous Stipulation and Agreement And Approving Application issued on April 26, 2005, and specifically in Ordered Paragraphs 3 and 4 of the Order as follows:

"3. That DTE Enterprises, Inc., may sell its limited partnership interest in Southern Missouri Gas Company, L.P., to Sendero SMGC Limited Acquisition Company, LLC.

4. That DTE Ozark, Inc., may sell its limited partnership interest in Southern Missouri Gas Company, L.P., to Sendero SMGC Limited Acquisition Company, LLC."

Joint Applicants respectfully request that the Notice Of Correction Nunc Pro Tunc be issued on or before Thursday, May 26, 2005.


