STAFF MOTION FOR EXTENSION TO FILE RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission (“Staff”), through the undersigned counsel, and for its *Motion For Extension To File Recommendation*, respectfully states the following to the Missouri Public Service Commission (“Commission”):

1. On August 19, 2009, KCP&L Greater Missouri Operations Company (“KCP&L-GMO” or “Company”) filed an *Application* with the Commission, which initiated this case and requested the Commission approve a sale of KCP&L-GMO’s Blue Springs Service Center (“service center”). The *Application* included a copy of the *Real Estate Purchase & Sale Agreement* (“*Sale Agreement*”) for the service center, and requested that the Commission approve the sale by October 13, 2009.

2. On August 20, 2009, the Commission issued its *Order Directing Staff Status Report* (“*Order*”). The Commission’s *Order* directed the Staff to file a status report by August 31, 2009, informing the Commission of a date by which Staff would file its recommendation.

3. On August 31, 2009, the *Staff’s Anticipated Recommendation Date* stated that if it timely received the information requested from KCP&L-GMO, the Staff anticipated filing its recommendation no later than October 6, 2009.

4. The Staff has diligently investigated the *Application*, however the Company has indicated to Staff through conversation and by its October 2, 2009 *Request For Change*

Of Order Date, that the Company requires an additional sixty (60) days to complete the terms of the *Sale Agreement*.

5. The Staff requests an extension until December 7, 2009, to file its recommendation in this matter. In particular, the Staff awaits the results of an environmental inspection to determine the level of contaminants, if any, that exist on the property subject to the *Sale Agreement*.

WHEREFORE, the Staff requests the Commission allow until December 7, 2009, to file its recommendation for the sale of KCP&L Greater Missouri Operations Company's Blue Springs Service Center.
