**STAFF'S MOTION TO CANCEL PREHEARING CONFERENCE AND FILING OF
PROCEDURAL SCHEDULE**

COMES NOW the Director of the Division of Manufactured Homes, Recreational Vehicles and Modular Units of the Public Services Commission ("Director" and "Commission") and for his *Motion to Cancel Prehearing Conference and Filing of Procedural Schedule* states to the Commission as follows:

1. On December 22, 2000, the Commission issued an *Order Granting Motion Reopening Case, Order Establishing Prehearing Conference, and Order Directing Filing of Procedural Schedule* in this matter. This order was in response to a motion to reopen the case filed by the Director on December 20, 2000. The Director filed this motion on the grounds that


the relief it had requested in his *Complaint* filed on June 14, 2000 had not yet been granted by the Commission.

2. Staff would respectfully suggest to the Commission that a prehearing conference and filing of a procedural schedule are unnecessary in this case, as an order of default has already been entered by the Commission, on October 12, 2000. Therefore, there are no outstanding issues to be resolved in the case, other than that of what sanctions the Commission would wish to impose. Staff would respectfully request the opportunity to present to the Commission its recommendation in this regard.

WHEREFORE, the Director prays that the Commission grant his *Motion to Cancel Prehearing Conference and Filing of Procedural Schedule*.


