## MOTION FOR EXPEDITED TREATMENT FOR APPROVAL OF ADOPTION NOTICE AND REVISED TARIFF SHEETS

COMES NOW Xspedius Management Co. of Kansas City, LLC ("Xspedius Kansas City"), by and through counsel and pursuant to 4 CSR 240-2.080(17), and for its Motion for Expedited Treatment for Approval of Adoption Notice and Revised Tariff Sheets ("Motion"), states as follows:

1. On July 9, 2002, the Commission issued an Order Granting Temporary Certificate of Service Authority ("Order") in this case. The Order required Xspedius Kansas City to file a tariff "at least seven days before the transfer of assets and customers, with the transfer date as the proposed effective date."

2. Contemporaneous with this Motion, Xspedius Kansas City is filing the required adoption notice and revised tariff sheets to adopt the interexchange and local exchange tariffs of the e.spire companies: Missouri P.S.C. Tariff No. 1 of ACSI Local Switched Services, Inc.; and P.S.C. Mo. NO. 2 of American Communication Services of Kansas City, Inc.

3. The Commission's rules, at 4 CSR 240-2.060(16)(C) require that the adoption notice and revised tariff sheets have an effective date not fewer than thirty (30) days after the filing date.

4. The thirty (30) day adoption notice and revised tariff sheet approval process creates a practical problem. The sale of e.spire's assets to Xspedius was approved by the Bankruptcy Court to be accomplished by July 8, 2002, or as soon thereafter as all necessary regulatory approvals could be obtained. Although the Missouri Commission was exceedingly swift in its approval of the transfer and the granting of temporary certificates of service authority, the regulatory approvals required from other jurisdictions have delayed the consummation of the transaction . However, this closing is now expected to occur on or about September 3, 2002. It is important that Xspedius Kansas City be in a position to provide service to its acquired customers as soon as the closing occurs. In order for Xspedius Kansas City to begin providing service to the transferred customers, it must have an effective tariff. Therefore, the effective date on the adoption notice and revised tariff sheets filed herewith is September 3, 2002, which is less than thirty (30) days following filing.

5. The Commission has already granted Xspedius Kansas City expedited treatment in this case and for the underlying and related cases, Case Nos. TM-2002-1155, XA-2002-1153, and LA-2003-0001, and it would be consistent with the Commission's other actions for it to permit the tariffs to take effect on less than thirty (30) days' notice.

6. Further, granting this Motion will in no way be detrimental to the customers being transitioned to Xspedius Kansas City or to any party in this uncontested case; in fact, it will ensure a seamless, uninterrupted transition of service from e.spire to Xspedius Kansas City for the benefit of the customers.

WHEREFORE, for the reasons stated above, Xspedius Kansas City respectfully moves the Commission to grant expedited treatment of Xspedius Kansas City's adoption notice and revised tariff sheets pursuant to 4 CSR 240-2.065(2).
