NOTICE OF DEFICIENCY AND ORDER DIRECTING FILING

On April 12, 2000, Cox Missouri Telecom, L.L.C. (Cox), filed its application requesting a certificate of service authority to provide basic local telecommunications service in portions of the state of Missouri. Commission Rule 4 CSR 240-2.060(1)(A) requires that, in addition to the legal name of the applicants, the application shall include the street and mailing address of the principal office or place of business of the applicants. The application fails to comply with Commission Rule 4 CSR 240-2.060(1)(A) because it does not specify the street and mailing address of its principal office or place of business. The applicant is directed to comply with Commission Rule 4 CSR 240-2.060(1).

In addition, the application states that Cox is a Missouri corporation duly organized and existing under and by virtue of the laws of the state of Missouri. However, the supporting documentation, a Certificate of Good Standing from the Missouri Secretary of State's Office, indicates that the applicant is a Delaware Limited Liability Company. The applicant also attached a Certificate of Formation from

the state of Delaware. Therefore, it is not clear whether applicant is a Missouri or Delaware Limited Liability Company. Applicant shall clarify its status as either a Missouri or a Delaware Limited Liability Company, and shall provide, if necessary, supporting documentation.

IT IS THEREFORE ORDERED:

- 1. That Cox Missouri Telecom, L.L.C., shall comply with 4 CSR 240-2.060(1) by amending its application to include the street and mailing address of its principal office or place of business, no later than May 15, 2000.
- 2. That Cox Missouri Telecom, L.L.C., shall amend, no later than May 15, 2000, its application to clarify its state of formation or incorporation and shall, if necessary, provide supporting documentation.
 - 3. That this order shall become effective on May 15, 2000.
