OFFICE OF THE PUBLIC COUNSEL'S OBJECTIONS TO REQUEST TO MAKE OPENING STATEMENT

COMES NOW the Office of the Public Counsel ("Public Counsel") and objects

to the request of the Missouri Alliance of Area Agencies of Aging, Missouri Association for the Deaf, Missouri Council of the Blind, National Silver Haired Congress, National Counsel of Silver Haired Legislatures, Paraquad, and St. Louis Gateway SeniorNet to make an opening statement in this proceeding. The Public Service Commission ("Commission") has granted participation without intervention as requested by the organization who have among their membership utility customers. The Commission has provided these organizations with an adequate opportunity to comment on their interest by filing a brief. Given the number of intervenors who have filed testimony and will be actively participating in the hearing, the request should be denied. The broad umbrella of Public Counsel's representation of the consumer and the public in this proceeding provides for representation of these consumers. The Commission's grant of filing of a post-hearing brief provides the organizations with an adequate opportunity to present their views if Public Counsel does not, in their opinion, present their view point on the public interest. These organizations have not prior to this application sought to participate in any

other telecommunications docket in recent years. They do not represent a unique and separate interest from all consumers.

WHEREFORE, Public Counsel objects to these organizations being allowed to make an

opening statement and asks the Commission to deny their motion.
