

KLM TELEPHONE COMPANY'S
THIRD REQUEST FOR EXTENSION OF TIME TO
FILE ANNUAL REPORT

Comes now KLM Telephone Company ("KLM") and for its Third Request for Extension to Time to File Annual Report states to the Missouri Public Service Commission (Commission) as follows:


1. KLM is a corporation organized and existing under the laws of the State of Missouri whose principal place of business is 616 E. Park, P.O. Box 30, Rich Hill, Missouri 64779. KLM is a "public utility" and a "telecommunications company" as those terms are defined in § 386.020 (42) and (51), RSMo Supp. 1999, subject to the control and jurisdiction of the Commission.

2. As a Missouri regulated utility, KLM is required to file an annual report with the Commission each year by April 15. Due to the elimination of the Primary Toll Carrier Plan and the institution of dialing parity in its exchanges, there have been changes in the sources of the company's revenue and in its accounting which has caused the preparation of its annual report to be delayed, and KLM was not able to complete and file its report by April 15. As a result, KLM requested extensions up to May 30, 2000 in which to complete and file its annual report.

3. Although KLM anticipates that it will be able to file the report within the next few days, because of the holiday and other matters, it was unable to do so by May 30, and thus requests another fifteen (15) days to complete and file its report.

Wherefore, KLM respectfully requests that the Commission grant its request for an extension of time up to June 15, 2000 to file its annual report and for any other relief appropriate in the circumstances.


