#### NOTICE OF DEFICIENCY

Missouri Telecom, Inc. (Mo. Telecom) filed an Application with the Missouri Public Service Commission (Commission) on January 5, 2000, for approval of a resale agreement between Southwestern Bell Telephone Company and Mo. Telecom (agreement).

Commission Rule 4 CSR 240-2.060(1)(A) requires, inter alia, all applications to the Commission to include the "...street and mailing address of the principal office or place of business of applicant..."

Mo. Telecom did not include the street and mailing address of the principal office or place of business of Mo. Telecom in its application as required by Commission Rule 4 CSR 240-2.060(1)(A).

Commission Rule 4 CSR 240-2.060(1)(B) requires all applications to the Commission to include a "...brief statement of the character of [the] business performed by [the] applicant." Mo. Telecom did not include a brief statement of the character of the business performed by Mo. Telecom in its application as required by Commission Rule 4 CSR 240-2.060(1)(B).

Commission Rule 4 CSR 240-2.060(1)(C) requires all applications to the Commission to include the "[n]ame, title, address and telephone number of the person to whom correspondence, communications and orders and decision of the commission are to be sent." Mo. Telecom did not include the name, title, address and telephone number of the person to whom correspondence, communications and orders and decision of the commission are to be sent in its application as required by Commission Rule 4 CSR 240-2.060(1)(C).

The agreement states that Mo. Telecom is a Missouri corporation. Commission Rule 4 CSR 240-2.060(4)(A) requires all applications to the Commission to include, "[i]f the applicant is a Missouri corporation, a certified copy of the Articles of Incorporation and a Certificate of Incorporation from the secretary of state..." Commission Rule 4 CSR 240-2.060(4)(E) states that if the information required by subsection (B) of that rule has been submitted by the applicant "...in a previous application, the same may be incorporated by reference to the case number in which the information was furnished." Mo. Telecom did not include a certified copy of its Articles of Incorporation and a Certificate of Incorporation from the secretary of state in its application as required by Commission Rule 4 CSR 240-2.060(4)(B); or, if such information has been submitted before, Mo. Telecom did not include a reference to the case number in which the information was furnished in its application as required by Commission Rule Commission Rule 4 CSR 240-2.060(4)(E).

The Commission cannot proceed with this case until Mo. Telecom complies with the Commission's rules by amending its application to cure the deficiencies as set forth above.
