
**NOTICE TO THE COMMISSION
CONCERNING STAFF'S ACTIVITIES**

COMES NOW the Staff of the Missouri Public Service Commission ("the Staff") and for its Notice to the Commission Concerning Staff's Activities in this case states as follows:

1. Staff attached a list of Best Practices concerning security measures to its December 31, 2001 Report to the Commission.
2. On February 6, 2002, this list of Best Practices was posted on the Commission's website and is available for users to access.
3. On February 11, 2002, the list of Best Practices was mailed to all Missouri utilities to assist them in their efforts to manage risks associated with emergency situations.
4. Staff also notes that the Commission updated its Internal Procedures Manual IP - 29, Emergency Response Procedures, in September 2001. Mr. Wess Henderson is the Commission's Disaster Coordinator and State Emergency Management Agency (SEMA) representative.
5. Staff will continue to compile responses it receives to the survey sent to utilities concerning preparedness for emergency situations and Staff will file an updated report to the Commission by June 1, 2002.
6. This Commission continues to participate in the Governor's Homeland Security Panel.

WHEREFORE the Staff moves this Commission to accept for filing this Notice.
