The Appellant expects to raise the following as issues in this matter, the Public Service Commission of the State of Missouri's (the "Commission") November 17, 2022 Amended Report and Order is unlawful, unjust, and unreasonable: (1) as to the Commission's decisions concerning the Office of the Public Counsel's proposed adjustment to account for the tax deduction that Evergy Missouri West, Inc. d/b/a Evergy Missouri West received as a result of the costs it incurred related to Winter Storm Uri; (2) as to the Commission's decision to calculate carrying costs using a long-term debt rate; and (3) as to the Commission's decision to use a discount rate to analyze recovery through securitization that is the same as the discount rate used to analyze recovery through customary ratemaking.
