**NOTIFICATION**

COMES NOW Union Electric Company d/b/a Ameren Missouri (Ameren Missouri or Company) and, pursuant to the terms of the *Unanimous Stipulation and Agreement Resolving Ameren Missouri's MEEIA Filing (Stipulation)*, submits the following:

1.     The *Stipulation* requires Ameren Missouri to file a notice in this case no less than five business days prior to making a change in its measure and/or incentive amount offering.<sup>1</sup>
2.     Ameren Missouri is discontinuing a measure that is currently found in two programs. It is discontinuing the Direct Install Advanced Smart Strip measure from both the Low Income program and the Home Energy Performance program.
3.     In accordance with the *Stipulation*, Ameren Missouri is providing notice of this change. Attached to this pleading is a list of incentives offered in Ameren Missouri's residential energy efficiency program with the changed incentives highlighted for ease of identifying where changes occurred. Also attached is a copy of the revised web pages.
4.     All of these changes have been discussed with the stakeholder group prior to this filing.

WHEREFORE, Ameren Missouri respectfully files this *Notice* in compliance with the terms of the *Unanimous Stipulation and Agreement Resolving Ameren Missouri's MEEIA Filing*.
