
1. The Company has main offices in Missouri located at 64 N. Clark St., Sullivan, MO 63080.
2. The Company seeks a state-issued franchise to provide video service in the following additional political subdivisions, which assess the following video service provider fee:

Crawford, County of	2%, applicable to Basic and Tier 1 only
Washington, County of	0%
Oak Grove Village	5%, applicable to Basic & Tier 1 only
Bland, City of	0%

3. Upon issuance, the state-issued franchise shall replace the local franchises in effect for the above-listed municipalities.

WHEREFORE, the Company requests that the Commission issue its order granting the Company video service authorization for the additional political subdivisions listed above.


