Comes now UtiliCorp United, Inc., d/b/a/ Missouri Public Service ("MoPub") and for its Motion to the Missouri Public Service Commission ("Commission") in the captioned matter states:

1. That on November 3, 1986, the Commission issued its Order Establishing Docket in this matter which ordered, among other things, that each company subject to the Commission's jurisdiction should report to the Commission the revenue requirement impact of the federal tax changes on 1986 Missouri jurisdictional operations on or before February 28, 1987;

2. That as noted in MoPub's comments filed in this docket on December 15, 1986, MoPub's annual audit in all probability will not be completed and the 1986 books and records will not be closed until the last week of February, 1987; that accordingly, it will not be possible for MoPub to meet the February 28, 1987, reporting date; that MoPub believes, however, that it will be able to make the subject filing deadline on or before March 30, 1987.

WHEREFORE, MoPub respectfully requests an order of this Commission extending the time for the filing of the revenue


