Comes now Complainant and moves for additional time in which to file a more definite statement and to extend pre hearing to later date for the following reasons:

1. On April 15, 2003, the Public Service Commission entered its Order Overruling the Respondent's Motion to Dismiss and granting its Motion for a More Definite Statement setting a deadline for Complainant to file a More Definite Statement on May 15, 2003. A Pre Hearing is set for May 29, 2003.

2. The Parties through their attorneys, Mr. Paul Boudreau and Mr. Terry Allen, have been in discussions in the interim, to amicably resolve the issues in light of the Order of the PSC and the Staff Report contained in the file. The Parties believe that they will reach a amicable resolution as a written proposal is on the table which should close this case. However the parties need an additional 15 to 30 days to finalize the settlement.

3. Consequently, Complainant requests an extension from the May 15, 2003 deadline in


which to file a More Definite Statement and an extension from the current pre hearing date.


