**MOTION FOR CORRECTION OF CO-MO COMM, INC.**

**COMES NOW** CO-MO COMM, INC. ("CO-MO"), by its undersigned counsel, and for its Motion for Correction hereby states as follows:

1. The Commission issued its Order Granting Application for Designation as an Eligible Telecommunications Carrier in this case on November 15, 2018.
2. In its Order, the Commission stated: "CO-MO is a mobile wireless carrier whose operations are not regulated by the Commission." Order, pg. 3.
3. CO-MO uses wireline (fiber-to-the-home) technology to provide high-speed broadband Internet access and Voice over Internet Protocol services. *See* Application for Designation as an Eligible Telecommunications Carrier, pg. 2. Further, CO-MO is certificated in the State of Missouri to provide video and Interconnected Voice over Internet Protocol (IVoIP) services. *See* Staff Recommendation, pg. 2 at ¶ 3.
4. Accordingly, CO-MO respectfully requests that the Commission correct the Order, by revising the statement set forth above by changing it to read: "CO-MO is a registered IVoIP provider in the State of Missouri."

**WHEREFORE**, CO-MO respectfully requests that the Commission correct its November 15, 2018 Order as set forth above and grant such other and further relief as the Commission deems appropriate.
