**MOTION FOR EXPEDITED TREATMENT**

COMES NOW Union Electric Company d/b/a AmerenUE (AmerenUE or the Company)  
and for its Motion for Expedited Treatment, states as follows:

1. Concurrent with this filing, AmerenUE is filing tariff sheets to amend its natural gas tariff sheets, specifically PSC. Mo. No. 2, Sheet No. 82. This sheet is part of AmerenUE's Missouri Energy Efficient Natural Gas Equipment Rebate Program.
2. The changes to this sheet increase the funds available for the program to \$187,000. This change is necessary because of a higher than anticipated response to this program by AmerenUE natural gas residential customers. The additional funds will be provided from the discontinued "Scott Stoddard Program" funds, left over from a previous rate case settlement (GR-2007-0003).
3. On November 13, 2009, this change was discussed with the Commission Staff, the Office of the Public Counsel and others as part of the Natural Gas Collaborative meeting.
4. This change will have no negative effect on AmerenUE customers and will, in fact, work to the benefit of all customers by increasing the number of AmerenUE customers who are able to participate in this program.

5. AmerenUE seeks expedited treatment for this tariff change and asks that the Commission approve the tariff no later than November 30, 2009. This pleading has been filed as soon as practical after the decision to seek this change was made.

WHEREFORE, for the reasons stated herein, AmerenUE respectfully requests that the Commission approve the tariff sheet filed herewith to take effect on November 30, 2009.
