**MOTION FOR EXPEDITED TREATMENT**

COMES NOW Laclede Gas Company (“Laclede Gas”), and submits this Motion for Expedited Treatment (this “Motion”) for approval by the Commission, stating as follows:

1. This filing accompanies a Unanimous Stipulation and Agreement (the “Agreement”) resolving all issues in the above referenced case. In the Agreement, the parties request that the Commission approve Tariff Sheet No. 12, a specimen copy of which is attached as Exhibit A to the Agreement and which has also been submitted in EFIS as a tariff filing.

2. In this Motion, Laclede Gas requests that the Commission act to approve the Agreement and ISRS Tariff Sheet No. 12 at its next agenda meeting on Wednesday, April 2, with an effective date of April 12, 2014. There is good cause for such expedited treatment since, pursuant to paragraph 15 of the Partial Stipulation and Agreement approved by the Commission in Case No. GR-2013-0171 (the “Rate Case Stipulation”), the parties have agreed to work to implement the Company’s ISRS filings as soon as reasonably possible.

3. Since this request is based upon the Rate Case Stipulation, which was signed by all of the Parties to this case and approved by the Commission, harm will be avoided, and the intent of the Parties and the Commission will be

served, by a Commission order approving the Agreement and directing the Company's ISRS tariff sheet to become effective April 12, 2013. Laclede Gas states that there will be no negative effect on Laclede's customers or the general public if the Commission issues such an order.

4. This pleading was filed as soon as it could have been following receipt and evaluation of the Staff Recommendation, and resolution of the issues that led to the Agreement.

**WHEREFORE**, for the foregoing reasons, Laclede Gas Company respectfully requests that the Commission issue its Order approving the Agreement and ISRS Tariff Sheet No. 12 filed of even date herewith, effective as of April 12, 2014.
