**MOTION FOR EXTENSION OF TIME  
TO FILE RECONCILIATION**

**COMES NOW** Liberty Utilities (Missouri Water) LLC (“Liberty Utilities” or “Company”), by and through counsel, and, for its Motion to For Extension of Time to File Reconciliation (“Motion”), states as follows to the Missouri Public Service Commission (“Commission”):

1.     On November 28, 2018, the Commission issued an Order Directing Reconciliation requiring that Liberty Utilities by December 10 file a reconciliation of the contested issues in this case. Liberty Utilities has been working with Staff to prepare a reconciliation for filing in this case and good progress has been made, but complexities associated with the specifying the rate design impacts have arisen causing some delay in generating the final document for filing. As such, it is unlikely that a reconciliation can be filed on December 10.

2.     Liberty Utilities requests that the Commission grant the Company a short extension of time for the filing of the reconciliation in this case. Specifically, the Liberty Utilities requests that the Commission grant an extension of seven (7) days until December 17.

3.     This Motion is not made to cause undue delay.

**WHEREFORE**, for good cause shown, Liberty Utilities requests that the Commission grant an extension to December 17, 2018, for filing of the reconciliation.
