**MOTION FOR EXTENSION OF TIME TO FILE A LIST OF ISSUES, ORDER OF
WITNESSES, ORDER OF CROSS EXAMINATION AND ORDER OF OPENING
AND
STATEMENT OF POSITIONS**

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and on its behalf, and that of Union Electric Company d/b/a Ameren Missouri, the Office of the Public Counsel, and the interveners¹ in this case, known collectively herein as “the Parties”, files this *Motion For Extension Of Time To File a List of Issues, Order of Witnesses, Order of Cross Examination and Order of Opening And Statement Of Positions (Motion)* with the Missouri Public Service Commission (Commission) respectfully stating the following:

1. Pursuant to the Commission’s February 29, 2012² Order establishing a procedural schedule, the Parties “...shall agree upon and Staff shall file a list of the issues to be heard, the witnesses to appear on each day of the hearing, the order in which they will be called, and the order of cross examination for each witness” by May 10.

2. Due to the Parties involvement in several MEEIA cases, surrebuttal filed today and an issue list due tomorrow in another MEEIA docket, at least three anticipated depositions in this matter next week, and the necessary leave of the Staff’s main witness, the Staff asks for additional time to work with the Parties. Staff has submitted a draft issue list to the Parties for their review and comment.

3. The Parties anticipate filing a joint issue list, order of witnesses and order of cross no later than May 15, and statements of positions no later than May 18. If the Parties cannot reach an agreement, the Parties will file separate lists for the Commission's consideration.

WHEREFORE, the Staff files this *Motion* requesting the Commission relieve the Parties from filing a list and statement of positions on the dates within the Commission's February 29 Order.
