## MOTION FOR LEAVE TO FILE CORRECTED TESTIMONY

COMES NOW the Midwest Energy Consumers Group (MECG), and respectfully requests leave to file corrected testimony of Kavita Maini. In support of this motion, MECG states:

- 1. On June 22, 2022, MECG filed the direct testimony of Kavita Maini.
- 2. When preparing to send the associated workpapers supporting that testimony to parties in the days that followed, MECG discovered an error in the table underlying Figure 8 on page 32 of Maini's testimony. The error relates to inadvertently carrying forward figures associated with Evergy West rather than Evergy Metro.
- 3. MECG circulated corrected workpapers to the parties via email and pointed out the error to counsel at that time. Because the information contained in Figure 8 is also referenced in the text of the testimony on p. 32, MECG seeks to submit a corrected substitute for page 32. The corrections are identified in tracked-change format in **Attachment 1** (Page 32 Metro Redlined).
- 4. Since these changes occur only on page 32 of Ms. Maini's testimony, MECG submits these corrections as a corrected substitute for that page rather than resubmitting the entire piece of testimony. A clean version of page 32 is included as **Attachment 2**. MECG does not believe submitting these corrections will prejudice any party's ability to address the underlying testimony in rebuttal.

WHEREFORE, MECG requests leave to file the attached corrected page 32 of Ms.

Maini's Direct testimony attached hereto as Attachment 2.
