THE FILING DATE FOR ITS ANNUAL REPORT**


COMES NOW TON Services, Inc. ("TON"), by and through its attorneys and, pursuant to 4 CSR 240-10.080(8), respectfully requests the Missouri Public Service Commission ("Commission") to extend the filing date for its Annual Report. In support of its request, TON states as follows:

1. TON is a certificated interexchange carrier in Missouri with its principal place of business located at 4185 Harrison Blvd., Suite 301, Ogden, Utah 84403.
2. As a telecommunications utility subject to the jurisdiction of the Commission, TON is required to file annual reports with the Commission each year by April 15, on a form provided by the Commission or on a computer generated replica which is acceptable to the Commission (4 CSR 240-10.080(1)&(4).
3. Although TON made diligent efforts to complete its 1999 Annual Report for submission by April 15, 2000, TON was not able to file a complete and accurate annual report by that date. Accordingly, TON attempted to file its 1999 Annual Report on April 21, 2000, with said document being returned by the Commission to TON with accompanying correspondence that date.

As a result, TON respectfully requests an extension of time to today, to file its attached Annual Report for the year ending December 31, 1999.

WHEREFORE, TON Services, Inc. respectfully requests, pursuant to 4 CSR 240-10.080(8), that the Commission grant its request for an extension of time to this date for filing its Annual Report, and for any other relief appropriate in the circumstances.
