

APPLICATION FOR EXTENSION OF TIME

COMES NOW Mid-Missouri Telephone Company, a certificated Missouri telecommunications company providing local exchange and exchange access service in the state of Missouri, pursuant to 4 CSR 240-3.540(4), and hereby requests that the Commission grant Mid-Missouri Telephone Company an extension of time until and including May 10, 2004, in which to file its calendar year 2003 Annual Report. In support of this Application, Mid-Missouri Telephone Company states as follows:

1. Section 392.210.1 RSMo. requires Mid-Missouri Telephone Company as a telecommunications company to file with the Missouri Public Service Commission an Annual Report.
2. 4 CSR 240-3.540(1) requires Mid-Missouri Telephone Company as a regulated telecommunications utility to file an Annual Report with the Commission on or before April 15 of each year.
3. Mid-Missouri Telephone Company desires its Annual Report to be based upon audited financial information, but audited information will not be available by April 15, 2004.
4. Mid-Missouri Telephone Company believes that audited financial information will be available in time to prepare and file the Annual Report in the required Missouri Public

Service Commission format on or before May 10, 2004, and requests an extension of time to and including May 10, 2004, in which to file same.

5. Pursuant to Rule 4 CSR 240-3.540(4), this written request is hereupon made to the Executive Secretary of the Missouri Public Service Commission for the Commission's consideration for approval.
