**MOTION FOR RECONSIDERATION AND
REQUEST TO WITHDRAW APPLICATION**

COMES NOW Cable One VoIP LLC d/b/a Sparklight (the “Company”), by its attorneys, and pursuant to 20 CSR 4240-2.160 respectfully moves the Missouri Public Service Commission (the “Commission”) to reconsider its Order Granting Designation as an Eligible Telecommunications Carrier (the “Order”) issued on August 25, 2021 in the above-referenced matter and to allow the Company to withdraw its Application for Eligible Telecommunications Carrier Designation and Request for Waiver of 20 CSR 4240-4.017 (“Application”). In support of this request, the Company states:

1. The Application was filed with the Commission on July 6, 2021 in the above-referenced docket. In the Application, the Company sought eligible telecommunications carrier (“ETC”) designation to provide Lifeline-only services in certain geographic areas of Missouri.
2. On August 25, 2021, the Commission issued the Order granting the Company’s Application. The Order is scheduled to take effect on September 24, 2021.
3. The Company no longer seeks ETC designation at this time. The Company currently is focused on providing service pursuant to the Emergency Broadband Benefit (“EBB”) Program administered by the Federal Communications Commission (“FCC”). The Company may

seek ETC status at a later date depending on the outcome of the potential future funding to replace the temporary EBB Program and the anticipated broadband funding under the federal *Infrastructure Investment and Jobs Act* (H.R. 3684) currently pending before the United States Congress.

4. Accordingly, the Company respectfully requests that the Commission reconsider the Order prior to the Order taking effect on September 24, 2021, allow the Company to withdraw its Application, and close this proceeding without prejudice. In the event the Company seeks to pursue ETC designation in Missouri in the future, it will file a new application under a new docket number.
