**ORDER APPROVING UNCONTESTED EXPEDITED TARIFF**

Issue Date: April 18, 2006

Effective Date: May 1, 2006

On April 4, 2006, McDonald County Telephone Company filed a Motion for Expedited Treatment regarding tariff sheets that it filed along with its motion. The motion explains that McDonald County Telephone's tariff sheets will authorize it to provide a new Custom Calling Service labeled Call Waiting ID, and two new Customer Calling packages, christened Basic Calling Feature Package and Extended Calling Feature Package. The motion states that McDonald County Telephone did not file its tariff sheets to implement the features earlier because of an unavoidable delay in their preparation. McDonald County Telephone's marketing plan for the new service and packages is scheduled to begin on May 1, 2006. The tariff indicates that it will become effective on May 4, 2006, but McDonald County Telephone requests that the Commission approve the tariff to become effective on May 1, 2006.

The Commission's Staff filed a recommendation regarding the proposed tariff on April 12, recommending that the Commission grant McDonald County Telephone's request for expedited treatment and approve the tariff to become effective on May 1, 2006.

The Staff describes the new Custom Calling Service offered by McDonald County Telephone, Call Waiting ID, as providing a subscriber with an incoming caller's telephone number during an outgoing call. The Staff summarizes the two new product packages as including various mixes of optional custom calling features subject to Monthly Recurring Charges (MRC). The Basic Calling Feature Package will include a promotional waiver of the installation Non-Recurring Charge (NRC) to new subscribers until May of 2007.

Based on the motion of McDonald County Telephone and the recommendation of the Commission's Staff, the Commission finds good cause to approve the submitted tariff on an expedited basis.
