ORDER GRANTING LEAVE TO FILE ANNUAL REPORT OUT OF TIME

Pursuant to 4 CSR 240-10.080(1), "[a]ll public utilities subject to the jurisdiction of the Missouri Public Service Commission shall file an annual report with the commission on or before April 15 of each year."

On May 24, 2000, American Farm Bureau, Inc. d/b/a The Farm Bureau Connection ("Farm Bureau"), filed a motion with the Commission requesting permission to file its 1999 annual report out of time.
