NOTICE CLOSING CASE

The Commission issued its Report and Order in this matter on December 23, 1997. The Report and Order specified language to be used by SWBT and AT&T to resolve the remaining interconnection issues, ordered SWBT and AT&T to submit an interconnection agreement implementing this language and the language which they had previously agreed to, and set interim rates for certain services to be provided to AT&T by SWBT. Since the issuance of the Report and Order, the parties have been using the interim rates.

On February 15, 2001, in Case No. TO-2001-438, the Commission issued an Order Establishing Case and Directing Notice, noting that certain areas of pricing, including the terms and conditions of those prices, need further review. Case No. TO-2001-438 will address, among other things, the recurring and nonrecurring rates found in the Commission's December 23, 1997, Report and Order in Case No. TO-98-115. Therefore, Case No. TO-98-115 may be closed.
