## Motion for Leave to File Conformed Agreement Out of Time

Comes now Petitioner Craw-Kan Telephone Cooperative, Inc., ("Petitioner") and requests the Missouri Public Service Commission ("Commission") to accept the filing of Petitioner's Notice of Filing of Conformed Agreement including the Petitioner's agreement with Cingular Wireless LLC, ("Cingular") out of time. In support of the request, Petitioner states as follows to the Commission:

The Commission issued its Arbitration Order on March 23, 2006, in the above-referenced consolidated case approving the Final Arbitration Report filed on March 3, 2006. The Commission directed the parties to incorporate the Commission's resolution of each contested issue into their Interconnection Agreements and to file the agreements no later than April 22, 2006. Following joint requests of the parties, the Commission extended the deadline to file the interconnection agreements until June 22, 2006.

Petitioner and Cingular have conferred and finalized a "template" interconnection agreement. The individual agreements for a large group of companies have now been finalized and filed.

The extensive process of executing the interconnection agreements involved preparing twenty-six interconnection agreements with Cingular (and twenty-three additional agreements with T-Mobile USA) with several unique provisions including the terms, rates, and circumstances. The process also included transmitting the agreements for signature to numerous locations, including several remote locations of the Petitioner's group of small Missouri rural telephone companies.

Cingular does not object to this request and joins in this request to the Commission.

WHEREFORE, the Petitioner respectfully requests this Commission to accept the Notice of Filing of Conformed Agreement and the attached agreement between Petitioner and Cingular out of time and for such other orders as the Commission deems appropriate. Respectfully submitted,
