**RESPONDENT'S MOTION FOR ORDER TO SHOW CAUSE AND TO SUSPEND THE
TIME FOR FILING PROPOSED PROCEDURAL SCHEDULE**

COMES NOW Union Electric Company d/b/a AmerenUE and for its Motion states as follows:

1. On June 22, 2010, the prehearing conference in this matter was convened. Samuel Ritchie, attorney for Staff, appeared in person. Cathy Hart representative for AmerenUE and Sarah E. Giboney, attorney for AmerenUE, appeared by telephone. The Office of Public Counsel did not appear. Complainant did not appear.

2. Because Complainant did not appear at the conference, the parties are unable to comply with that portion of the Commission's Order dated June 1, 2010, that requires the parties to jointly prepare and file a proposed procedural schedule no later than June 29, 2010, and will also be unable to prepare for an evidentiary hearing on the Complaint.

3. 4 CSR 240-2.090(5) allows the Commission to dismiss a party from a case or dismiss a party's complaint for failure to appear at a prehearing conference or participate by telephone, unless good cause for the failure to appear is shown.

WHEREFORE, AmerenUE respectfully requests that the Commission issue an order:

- A. requiring Complainant, within such time established by the Commission, to show cause why his Complaint should not be dismissed; and
- B. indefinitely suspending the time for the parties to jointly prepare and file their proposed procedural schedule until a reasonable time after Complainant has responded to the order to show cause.

AmerenUE represents to the Commission that it has conferred with Staff regarding the relief requested in this Motion and Staff has consented to the relief requested in the Motion.
