MOTION OF INTERVENORS FOR LOCAL PUBLIC HEARINGS

Come now Boatmen's First National Bank of Kansas City,
Kansas City Southern Industries, Inc., Cathedral of the
Immaculate Conception, Denson One Hour Optical, Inc., The
Ashley Building Partnership, Gailoyd Enterprises Corporation,

"Intervenors", by and through their attorneys of record, and
move that the Public Service Commission hold local public
hearings in connection with KCP&L's steam heat conversion
plan. In support of the Motion, Intervenors would suggest
as follows:

Intervenors are eleven entities which have intervened in support of the KCP&L steam heat conversion plan. However, Intervenors represent only a small portion of the KCP&L steam heat customers within the affected area. Intervenors believe that local public hearings on the intervention issue could be beneficial to the Public Service Commission in terms of making its decision relative to the proposed steam heat conversion plan.

The need for local public hearings is underscored by the fact that early in December the consultant retained by the Public Service Commission contacted certain steam customers in order to get input relative to the conversion plan. However, this group of customers, like the Intervenors, is a small group, and the Intervenors believe that more information could be adduced through local public hearings.

Although it is currently contemplated that written testimony is to be submitted by February 2, 1987, Intervenors see no reason that the proposed local public hearings could not be held subsequent to February 2, 1987. For that matter, although Intervenors would prefer to see the local public hearings held before the hearing scheduled for March 9, 1987, in that the proposed local public hearings are suggested to give the Public Service Commission additional community input, the local public hearings could be held after the currently scheduled hearing (March 9 through March 13, 1987).

For the foregoing reasons, the Intervenors respectfully request that the Public Service Commission schedule local public hearings as requested by Intervenors.
