Come now Intervenor, Doe Run Company, a partnership of St. Joe Minerals Corporation and Homestake Lead Mining Company of Missouri, and Intervenor, ASARCO, Inc., by and through their counsel, and for their Reply to the Response of Arkansas Power & Light Company to Motion to Suspend Phase-In Tariffs, respectfully states to the Commission as follows:

1. The allegations set forth in Paragraphs 1 through 6 are refuted by the record of the proceeding in Case Number ER-85-265 and by the record of the proceeding in Case Number AO-87-48; and, therefore, no reply will be made to those allegations.

2. Replying to the allegations set forth in Paragraph 7, counsel for Arkansas Power & Light Company obviously read the cover letter in which filing was made in Case Number AO-87-48 and not the cover letter of Case Number ER-85-265. It is clearly indicated by that cover letter, a copy of which is attached hereto, that an original and thirteen (13) copies were submitted to the Commission.
