



possible, SUG, LG and Laclede Gas also intend to consult, as schedules permit, with the attorneys and relevant subject matter experts from the Commission Staff, the Office of the Public Counsel and the other parties between now and the date of the technical conference to identify and discuss specific areas of interest or concern that may be the subject of further discussions at the technical conference.

WHEREFORE, SUG, LG and Laclede Gas respectfully move the Commission to issue its Order directing that an early technical conference be held in this matter in the Commission's offices in Jefferson City, Missouri on Monday, March 18, 2013, commencing at 1:00 p.m.
