### **MOTION FOR EXPEDITED TREATMENT**

Comes now Aquila, Inc., d/b/a Aquila Networks - MPS (“MPS”), and, as its Motion for Expedited Treatment, states to the Missouri Public Service Commission (“Commission”) as follows:

1. Concurrent with this Motion, MPS is filing four “blank” tariff sheets related to its natural gas transportation tariff with an issue date of July 16, 2003 and an effective date of August 15, 2003.
2. Aquila Networks - MPS previously filed tariff sheets on June 23, 2003, designed to clarify and correct certain aspects of the natural gas tariffs and to add a large volume schedule to a transportation program previously approved by the Commission (Tariff No. JG-2003-2216). The blank sheets attached hereto are necessary to complete those changes.
3. Because the substantive tariff sheets (Tariff No. JG-2003-2216) carry an effective date of July 23, 2003, and because the subject sheets are merely blank pages, MPS seeks the Commission’s expedited treatment of these tariff pages. To that end, MPS asks that the tariff sheets become effective on July 23, 2003.

WHEREFORE, for all the foregoing reasons, Aquila Networks - MPS respectfully requests the Commission to consider this Motion for Expedited Treatment and to approve the proposed tariff

sheets effective July 23, 2003.


