MOTION FOR EXPEDITED TREATMENT OF TARIFFS

COMES NOW Southern Missouri Gas Company, L.P. ("SMGC" or "Company"), by and through its attorneys, pursuant to 4 CSR 240-2.080(17) and 4 CSR 240-2.065(2), and requests that the Missouri Public Service Commission ("Commission") expedite the approval of its tariffs, for good cause shown, and permit the Company to make effective on December 12, 2003, the substitute tariffs filed on November 21, 2003, in this proceeding. In support of this Motion, SMGC respectfully states:

1. On September 30, 2003, SMGC filed proposed tariff sheets implementing a new service entitled "Supply Coordination and Delivery Service" and provisions related to capacity release revenues and off-system sales. The proposed tariffs had an issue date of September 30, 2003, and an effective date of October 30, 2003.
2. On October 21, 2003, SMGC filed its Extension Letter extending the effective date of the tariffs from October 30, 2003, to November 30, 2003.
3. SMGC, Staff and Public Counsel have held discussions concerning the proposed tariffs and have reached an agreement regarding appropriate tariff language to implement the new service. This agreed-upon language is contained in substitute tariff sheets filed concurrently

with this motion. These substitute tariff sheets have a thirty (30) day effective date of December 21, 2003, as requested by Staff.

4. The Supply Coordination and Delivery Service is intended by SMGC to be available for use by two industrial customers when their existing internal transport contracts are terminated by December 16, 2003, pursuant to the terms of the Commission's Order Approving Stipulation and Agreement in Case No. GC-2004-0314 (issued on November 6, 2003).

5. SMGC respectfully requests that the Commission approve its substitute tariff sheets to be effective on December 12, 2003. The expedited approval of the substitute tariff sheets will ensure that Supply Coordination and Delivery Service will be available upon the termination of the internal transport contracts that were the subject of Case No. GC-2003-0314.

6. This pleading is being filed as soon as it could have been following the agreement of SMGC, Staff and Public Counsel regarding the appropriate tariff language in this proceeding.

WHEREFORE, Southern Missouri Gas Company, L.P., respectfully requests that the Commission authorize its tariffs to go into effect on an expedited basis and no later than December 12, 2003.
