Memorandum

On November 5^{th,} 2009 I performed an inspection on R. D. Sewer Company (the Company) pursuant to the Commission's Report and Order in Case No. SO-2008-0298, which included the following ordered paragraph:

15. Beginning on November 1, 2009, the Staff of the Missouri Public Service Commission shall commence annual inspections of R. D. Sewer Company, L.L.C. and shall within thirty days of completing those inspection file with the Commission a report describing the operating conditions of R. D. Sewer Company, L.L.C.'s waste water treatment plant.

During my inspection I observed that the waste water plant was operating properly. The effluent and receiving streams both were clear and the effluent appeared to be meeting discharge limits. The fence, which had been damaged by falling limbs from an ice storm, was repaired. There are repairs being made to the building that houses the blowers and motors but this was not complete. The necessary repairs to the building do not affect the performance of the waste water plant. Trash around the plant has been removed and a dumpster was on site to dispose of trash. Proper disposal of trash, fence repair, and repair to the blower building were conditions of the Unanimous Disposition Agreement entered into and approved by the Commission in Case No. SR-2009-0226.

I contacted DNR and confirmed that the Company is submitting samples according the discharge permit issued for the facility. DNR did issue a notice of violation in August of 2009. The Company stated this was due to high flows from infiltration. The Company has located and fixed some infiltration problems and is continuing to make efforts to decrease infiltration.

R. D. Sewer, DNR, and the Attorney General's office are still negotiating monies owed to DNR and if the Company will have to enter into a bilateral compliance agreement to resolve other previous violations; most of which occurred under the operations of the previous owner of the waste water plant Stoddard County Sewer. As of the date of my inspection, no resolution had been reached.
