MOTION FOR EXPEDITED TREATMENT

COMES NOW Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri" or "Company") and, pursuant to 4 CSR 240-2.160, submits its Motion for Expedited Treatment and states as follows:

1. A Stipulation was filed in Ameren Missouri's 2012 electric rate case (Case No. ER-2012-0166) on September 28, 2012, titled *Non-Unanimous Stipulation and Agreement Regarding Certain Revenue Requirement Issues* ("Stipulation").

2. The Commission issued an order effective October 20, 2012, approving the Stipulation.

3. Consistent with the Stipulation, Ameren Missouri is to file a new electric rate schedule that combines its two tariff schedules as one tariff. That filing is to be made no later than January 31, 2013. In order to be able to make that filing, the Company cannot have any pending changes to its tariff schedules.

4. 4 CSR 240-3.155 and 4 CSR 240-20.065 require the Company to file revised tariffs in each odd-numbered year, no later than January 15th. These revised tariff sheets will need to be included with the new electric rate schedule to be filed on January 31, 2013, as discussed in paragraph 3 above.

5. This filing revises the Company's net metering and cogeneration tariff sheets to modify the Company's rates paid for energy purchased from customers with a

Qualifying Facility (4 CSR240-3.155, 4 CSR240-20.060) or Net Metering (4 CSR240-20.065) installation. It will also correct a typographical error on Sheet 19 of the Net Metering tariff.

4. Ameren Missouri requests these revised tariff sheets be approved so they are effective on January 24, 2013 and can be included in the new electric rate schedule filing which is due on or before January 31, 2013.

5. Ameren Missouri has filed this request for expedited treatment as soon as possible after deciding the change was necessary and after discussing this matter with the Commission Staff. There will be no negative effect on the party's customers or the general public in granting this expedited treatment request.

WHEREFORE, Ameren Missouri respectfully requests the Commission issue an order approving the revised tariffs so that it is effective no later than January 24, 2013.
