Dear Judge Woodruff:

Paragraph 34 of the Stipulation and Agreement (on page 37 of 43) filed in the referenced case on July 2, 2013, states that “[p]rior to the closing of this transaction, SUG and Laclede Gas Company shall obtain all necessary authorization under Sections 7(b) and 7(c) of the National Gas Act in FERC docket CP13-497-000.” On July 12, 2013, the Federal Energy Regulation Commission (FERC) issued an Order Approving Abandonment and Issuing Limited Jurisdiction Certificate in its docket number CP13-497-000 pursuant to which it has approved a joint application filed by Southern Union Company d/b/a Missouri Gas Energy (SUG) and the Laclede Gas Company (Laclede Gas) seeking authorization for SUG’s MGE division to abandon its limited jurisdiction certificate to provide transportation on a no-fee gas exchange basis in Missouri and granting to Laclede Gas a limited jurisdiction certificate to continue to provide the same no-fee exchange service utilizing the same facilities. A copy of the FERC order is attached

for the Commission's information. A copy of this communication is also being provided to all parties of record.
