

1.0 Summary

The U.S. Army Corps of Engineers (USACE) concluded their consultation with the Osage Nation in December. Conclusion of this process will allow USACE to issue the Section 404 Clean Water Act permit, which is expected to occur in mid-January. With more certainty regarding permit timing, the Project Company issued notice to proceed to the EPC contractor (Mortenson); however, until the 404 permit is issued, Mortenson will work only in areas that are outside of USACE jurisdiction and not of significance to the Osage Nation. Mortenson has mobilized to the project site in December and performed some site preparation activities.

2.0 Safety

There were no safety incidents at the site during the month of December. As headcount and activity on site increases, so will the detail of safety reporting provided in future issues of this report.

3.0 Project Schedule

The Project Company satisfied one of its remaining development milestones when notice to proceed (NTP) was issued to the EPC contractor (Mortenson) in December. The Section 404 Clean Water Act permit has not yet been issued but is expected in early Q1 2020. Once the Section 404 permit has been issued and no longer contributes to ongoing schedule uncertainty, a detailed construction schedule will be provided in future issues of this report.

4.0 Development Activities

Development activities for the period were focused on the Section 404 Clean Water Act permit. As discussed in Progress Report 2, the U.S. Army Corps of Engineers (USACE) is required to consult with a number of Native American Nations before issuing the Section 404 CWA permit. This consultation process continued in December, as USACE and the Osage Nation scheduled a meeting early in the month. That meeting did not take place however, as the Osage canceled shortly before it was scheduled to occur. The USACE deemed that sufficient opportunity for consultation had been afforded to the Osage, and issued a letter concluding the consultation process. With that process complete, the Project Company anticipates permit preparation will begin when USACE personnel return from their holiday break and that the Section 404 permit will be issued in mid-January. The Project Company began implementation of the Monitoring and Inadvertent Discovery (MID) plan on December 17 with training of Mortenson project management and field personnel. The purpose of the MID plan is to address the discovery of unanticipated cultural items.

The Project Company's initial payment to Empire under the Interim Generator Interconnection Agreement was received in December. This is payment for construction of the point of interconnection and network upgrades at the Asbury Plant substation.

5.0 Construction Activities


Engineering on the project wrapped up on the project in December with the IFC issue of the substation designs on December 16.

With notice to proceed issued to Mortenson, construction activities commenced. Mortenson mobilized to the site on December 16, and received training on the MID plan on December 17. Mortenson began site preparation activities at the laydown yard and substation site, including installation of erosion controls, tree clearing and topsoil stripping.

According to the latest progress reports provided by Siemens, final assembly of the main power transformer will be completed on January 3, and acceptance testing will begin the following Monday, January 6. Empire has arranged for Burns & McDonnell to witness factory acceptance testing in Mexico. Delivery to the project site is currently scheduled for March 2. There have been no manufacturing issues reported to date.

6.0 Project Cost Report

Expenditures during November totaled **______**. Project expenditures to date are **______** of the total budgeted expenditure of **______**. The increase in spending in November over previous months is due to an accrual for significant work completed by Burns & McDonnell on the construction of the point of interconnection upgrades at the Asbury Plant substation. An initial payment for this work was received from the Project Company in December and will be reflected in the next project cost report. There have been no increases to the anticipated total capital expense at completion. See the next page for a report detailing expenses by budget category.


