MOTION FOR EXTENSION OF TIME TO FILE TARIFF

Comes now Allegiance Telecom of Missouri, Inc. ("Applicant" or "Allegiance"), by its undersigned counsel, and pursuant to the Commission's *Order Granting Certificate To Provide Basic Local And Exchange Access Telecommunications Services* issued in this case on October 7, 1999, for its Motion For Extension Of Time To File Tariff, respectfully states as follows:

1. The Commission's Order issued in this case on October 7, 1999 required, *inter alia*, Allegiance to file its proposed tariff bearing a 45-day effective date within 30 days after the effective date of a Commission order approving Allegiance's interconnection agreement with an incumbent local exchange telecommunications company.

2. On September 1, 1999 Allegiance filed its Interconnection Agreement with Southwestern Bell Telephone Company. That case was docketed as Case No. TO-2000-202. On October 29, 1999 the Commission issued its *Order Approving Interconnection Agreement* in Case No. TO-2000-202, which became effective on November 8, 1999.

3. By virtue of the Commission's Order issued in this case, therefore, Allegiance's proposed tariff would be due to be filed on or before December 8, 1999.

4. Allegiance has not yet finalized its proposed initial Missouri tariff, despite its best


efforts, and therefore is unable to meet the December 8, 1999 filing deadline established by the Commission. At this time Allegiance's tariff consulting firm is in the process of finalizing Allegiance's proposed tariff for Allegiance's internal review. Once the tariff is finalized and the necessary internal reviews are completed, Allegiance intends to promptly file its proposed tariff with the Commission.

5. Given the upcoming holiday, Allegiance estimates that it should be ready to file its proposed tariff within the next forty-five (45) days. Allegiance will, however, file its tariff before that time if at all possible.

6. No other party should be harmed in any way by the Commission granting this request.

WHEREFORE, Applicant Allegiance Telecom of Missouri, Inc. respectfully requests that the Commission grant a forty-five day extension of time for Applicant to file its proposed tariff on or before January 21, 2000.
