MOTION FOR CLARIFICATION OF ORDER
AND CORRECTION NUNC PRO TUNC

COMES NOW LMDS Holdings, Inc. ("Holdings") pursuant to 4 CSR 240-2.160 and for its Motion for Clarification of Order and Correction Nunc Pro Tunc states to the Commission as follows:

1. On February 8, 2006 the Commission herein issued its Order Granting Certificates.
2. As confirmed on page 1 of the Order, LDMS "applied for certificates of service authority to provide basic and non-switched local exchange, as well as interexchange telecommunications service."
3. On page 2, the Commission indicated that "granting such certificates is in the public interest." The Commission also approved LMDS' tariff, which covers non-switched local exchange service.
4. However, in items 1 and 2 on page 5, the Commission only expressly granted certificates to provide basic local and interexchange services. Further, the Commission did not expressly state that services other than basic local are authorized statewide.
5. To avoid confusion in the future, LDMS respectfully requests the Commission to clarify its order and correct it *nunc pro tunc* by revising item 2 on page 5 to state: "LDMS Holdings,

Inc., is granted certificates of service authority to provide non-switched local exchange and interexchange telecommunications services in the State of Missouri.

WHEREFORE, LMDS Holdings, Inc., respectfully requests the Commission to clarify its February 8, 2006 Order and correct it *nunc pro tunc*.
