**MOTION FOR EXPEDITED TREATMENT**

COMES NOW Union Electric Company d/b/a AmerenUE (AmerenUE or the Company)  
and for its Motion for Expedited Treatment, states as follows:

1. Concurrent with this filing, AmerenUE is filing tariff sheets to amend its natural gas tariff PSC. Mo. No. 2, Sheet No. 34, titled Infrastructure System Replacement Surcharge (ISRS).

2. This tariff sheet implements the order issued by the Missouri Public Service Commission in this docket on August 12, 2009, which approved ISRS rates for AmerenUE but rejected the tariff the Company had originally filed. The Commission directed AmerenUE to refile the ISRS tariff to conform to the ISRS amount contained in the order. The Commission's order contained an effective date of August 22, 2009.

3. AmerenUE is filing this tariff sheet with a 30 day effective date, but asks the Commission to grant expedited treatment and to make the sheet effective on September 1, 2009.

4. This pleading has been filed as soon as was practical after the Commission's order was issued.

WHEREFORE, for the reasons stated herein, AmerenUE respectfully requests that the Commission approve the tariff sheet filed herewith to take effect on September 1, 2009.
