**Ameren Missouri's Motion for Extension of Time to File Response**

COMES NOW Union Electric Company d/b/a Ameren Missouri (Ameren Missouri) and for its Request for Extension of Time to File Response, states as follows:

1.       The Office of the Public Counsel (OPC) filed motions to open the above cited case on November 2, 2010.

2.       On that same date, the Missouri Public Service Commission (Commission) issued its Order Consolidating Cases, Directing Notice, Setting Intervention Deadline and Directing Filing (Order). The Order sets an intervention deadline of November 9, 2010 and directs Ameren Missouri to file its response to OPC's pleadings no later than November 5, 2010. Ameren Missouri has not yet received mail service of this order nor has it received electronic (email) notification of the order from the Commission's EFIS system.

3.       Ameren Missouri requests the Commission allow it until November 9, 2010 to file its response to OPC's pleadings. Responding to OPC's pleadings will require more than three days. Additionally, several of the individuals needed to put together a response will be at the Commission for a workshop all day on Thursday and/or have other commitments which make them unable to work on the Company's response to OPC's pleadings.

WHEREFORE, Ameren Missouri respectfully asks the Missouri Public Service Commission to allow it additional time, until November 9, 2010, to respond to the pleadings filed by the Office of the Public Counsel.
