MOTION FOR EXTENSION OF TIME AND SUSPENSION OF PROCEDURAL SCHEDULE

Comes now Missouri Gas Energy (MGE), a division of Southern Union

Company, in this matter, by and through its attorney, and asks the Commission to grant
an extension of time for the filing of Staff's recommendation in this case until May 31,
2002, and for the suspension of the present procedural schedule. In support thereof,
MGE respectfully states as follows:

- 1. Representatives of Staff, MGE and OPC have had recent discussions regarding the subject matter of this proceeding and related matters. MGE believes that a short delay in the scheduled filing of Staff's recommendation in this case may be beneficial from the standpoint of potentially eliminating some complex issues which otherwise would require lengthy litigation. The Staff's recommendation is presently due this date (April 12, 2002). To facilitate additional discussions and the exchange of additional information, MGE requests that the Commission allow the Staff additional time before its recommendation has to be filed.
- 2. MGE requests that the Staff be allowed an extension on the filing of the recommendation until May 31, 2002. In addition, MGE and the Staff have agreed that the Staff should file an update or status report in this case with the Commission on or

before May 3, 2002, to give the Commission an indication of the status of the discussions.

3. Counsel for MGE has had discussions with counsel of record and understands that there is no objection to this motion.

WHEREFORE, MGE requests that the Commission issue an order suspending the procedural schedule in this case, order the Staff to file a status report in this case on or before May 3, 2002, and to file its recommendation in this case on or before May 31, 2002.
