**LAKE REGION WATER & SEWER COMPANY'S
MOTION FOR EXTENSION OF TIME TO SUBMIT FORM OF CUSTOMER NOTICE**

COMES NOW Lake Region Water and Sewer Company ("Lake Region") and for its motion for extension of time to submit form of customer notice states as follows:

1. By order dated August 29, 2013, the Commission directed Lake Region to submit a proposed customer notice regarding the local public hearing no later than September 10, 2013. This request for an extension is out of time.

2. Following prehearing conference in these matters convened on August 22, 2013, the parties discussed whether a customer notice used and approved in a previous Lake Region rate case might have usefulness in the present cases, the object of that discussion being a possible agreement on the notice form in advance of the filing due on September 10, 2013.

3. Because of competing schedules the parties and their representatives have not been able to resume active discussions on the form of customer notice and the deadline to submit the same was missed.

4. Lake Region submits that with additional time, the parties can reconvene on the form of notice and will likely arrive at an agreed form to submit for Commission approval within the next seven days.

5. The delay in meeting the Commission's deadline was not for purposes of delay but for reasons and circumstances Lake Region asks the Commission to deem excusable.

6. Neither the public nor the other parties will be prejudiced by the extension sought by Lake Region and fairness and justice would be served thereby.

WHEREFORE, Lake Region requests that the Commission accept this request out of time and further extend the time within which Lake Region submits for Commission approval the form of customer notice by seven days up to and including September 17, 2013, with a corresponding extension of any other affected deadline.
