**OBJECTION TO NON-UNANIMOUS  
STIPULATION AND AGREEMENT FILED OCTOBER 19, 2012  
(CORRECTED)**

Comes now the City of Kansas City, Missouri (the City) and pursuant to 4 CSR 240-2.115(2) objects to the *Non-Unanimous Stipulation and Agreement as to Certain Issues* (the Stipulation) filed by the signatory parties thereto on October 19, 2012 and respectfully submits the following:

1. This objection, having been filed within seven days of filing of the Stipulation, is timely.

2. Specifically, the City objects to the parties' stipulated resolution of "Issue II.14 **Low Income Weatherization**" found on pages 7 and 8 of the Stipulation and moves the Commission to set the issue for hearing.

3. In its *Order of Opening Statements, Revised Schedule of Issues and Additional Witnesses* entered on October 15, 2012, the Commission originally set this issue for hearing starting on Monday, October 29, 2012 noting however that the testimony of Dr. Adam Bickford, a witness for the Missouri Department of Natural Resources, would be taken earlier on October

18, 2012. The City proposes that the hearing on this issue be set for October 29, 2012, as initially scheduled, and that the testimony of Dr. Bickford be taken up at a time and date as soon as conveniently possible for all parties thereafter.

4. Pursuant to 4 CSR 240-2.115, the City states that it does not oppose the balance of the issues addressed and resolved in the Stipulation except to the extent they may affect consideration and disposition of Issue II. 14.

WHEREFORE, having asserted its objection to the Stipulation, the City respectfully requests that Issue II.14 **Low Income Weatherization** be scheduled for hearing.
