ANNUAL REPORT OUT OF TIME**


Comes now Fidelity Communications Services I, Inc.'s ("Fidelity" or "Company") and for its Motion for Leave to File Annual Report Out-of-Time states to the Missouri Public Service Commission ("Commission") as follows:

1. Pursuant to 4 CSR 240-10.080(1), all public utilities subject to the jurisdiction of the Commission shall file an annual report on or before April 15. Fidelity is a telecommunications company subject to the jurisdiction of the Commission.

2. Due to the recent certification of several new competitive companies and the fact that the family of Fidelity companies now totals thirteen (13) companies, the year end audit of the companies was more complicated and consumed more time than in the past. Because the audit took more time than was originally scheduled, Fidelity was not able to complete its Annual Report in time to file with the Commission by April 15. Fidelity respectfully requests that the Commission grant its Motion for Leave to File Annual Report Out-of-Time and accept the report for filing. No party should be prejudiced by the inadvertent delay.

Wherefore, Fidelity respectfully requests that the Commission grant its Motion for Leave to File Annual Report Out of Time and accept the attached 1999 Annual Report for filing.


