MOTION FOR EXTENSION OF TIME

COMES NOW the Director of the Division of Manufactured Homes, Recreational Vehicles, and Modular Units of the Public Service Commission ("Director" and "Commission") and for his *Motion for Extension of Time* states as follows:

1. On May 4, 2001, the Commission issued its *Order Changing Deadline for Filing of Procedural Schedule*, in which it directed the parties to file their procedural schedule in this matter no later than June 8, 2001.

2. The Director and Rightway Homes ("Respondent") are in the process of reaching a proposed settlement in this matter to submit to the Commission for its approval.

Unfortunately, all of the persons necessary to consent to this proposal will not be available until Monday, June 11, 2001, as they are out of reach because of business. The Director and

Respondent fully expect to have a proposal to submit to the Commission within the next week, and no later than June 15, 2001.


3. Counsel for the Director has spoken with counsel for Respondent, as well as counsel for the Office of the Public Counsel, who have no objection to the granting of this motion.

4. 4 CSR 240-2.050(3) provides that “[w]hen an act is required or allowed to be done by order or rule of the commission at or within a specified time, the commission, at its discretion, may – (A) Order the period enlarged before the expiration of the period originally prescribed or as extended by a previous order....”

WHEREFORE, the Director prays that the Commission grant his *Motion for Extension of Time*, pursuant to 4 CSR 240-2.050(3)(A), for the reasons set out above.


