

On September 01, 1999, Missouri State Discount Telephone filed an Application for Certificate of Authority and for Competitive Classification. On March 09, 2000, the Commission issued an order that directed the parties to appear for an on the record presentation regarding the stipulation and agreement. The on the record presentation was scheduled for March 24, 2000.

Missouri State Discount Telephone regrettfully did not receive notification to appear. Staff, Southwestern Bell, the Small Telephone Group, and the Mid- Missouri Group of Local Exchange Companies did appear. All of the Commissions questions were unable to be answered about MSDT's application.


