MOTION FOR EXTENSION OF TIME TO FILE TARIFF

COMES NOW Fidelity Communication Services II, Inc., ("FCS II") and hereby requests an extension of time to file the initial tariff. In support of its Motion, FCS II states as follows:

1. FCS II applied to the Missouri Public Service Commission ("Commission") on September 10, 1999, for a certificate of service authority to provide basic local and local exchange telecommunications services in Missouri under Sections 392.420-.440, RSMo 1994, and Sections 392.410 and 392.450, RSMo Supp. 1998. FCS II asked the Commission to classify it as a competitive company and waive certain statutes and rules as authorized by Sections 392.361 and 392.420. FCS II is a Missouri corporation with principal offices located at 60 North Clark Street, Sullivan, Missouri 63080.

2. The Commission issued a notice and schedule of applicants on September 14, 1999, directing interested parties wishing to intervene to do so by October 14, 1999. On October 7, 1999, Southwestern Bell Telephone Company ("SWBT") filed its application to intervene which was granted on October 21, 1999. No other entity intervened.

3. The parties filed a Stipulation and Agreement ("Agreement") on November 15, 1999. The Staff of the Commission filed Suggestions in Support of the Stipulation and Agreement on November 17, 1999.

4. The Commission, on November 30, 1999, entered the Order Granting FCS II a Certificate to Provide Basic Local and Exchange Access Telecommunications Services ("Order") and ordered FCS II to file a tariff within 30 days after the effective date of a Commission order approving an interconnection agreement that will allow FCS II to provide services.

5. On August 22, 2000, the Commission entered an Order under Case No. TO-2000-758 recognizing FCS II's adoption of the GTE Midwest Incorporated and GTE Arkansas Incorporated and AT&T Communications of the Southwest, Inc. interconnection, resale and unbundling agreement.

6. Accordingly, FCS II's tariff is due on September 22, 2000. FCS II is still developing its tariff and has not completed its work.

WHEREFORE, Fidelity Communication Services II, Inc., respectfully requests an extension of time to file its initial tariff no later than 3:00 PM on November 21, 2000.
